Applications are invited for one post of Accounts Officer and three posts of Junior Accounts Officer at University Grants Commission, New Delhi and three post of Accounts Officer for University Grants Commission, Regional Offices (one each at WRO-Pune, NERO-Guwahati and ERO-Kolkata) on deputation basis on Foreign Service terms in the scale of pay of Rs.7450-225-11500 and Rs.5500-175-9000 respectively. The posts are to be filled on deputation basis (foreign service) initially for one year extendable upto three years from the SAS/JAO examination passed officers in organized Accounts Cadre of Govt. of India on usual terms and conditions laid down in Govt. of India, Ministry of Personnel & Training OM No.2/29/81-Estt.(Pay.II) dated 05.01.1994 as amended from time to time.
