Circular for inviting proposals from the Colleges located in Haryana, Himachal Pradesh, Jammu & Kashmir, Punjab, Chandigarh, Uttar Pradesh and Uttaranchal for different schemes.

The University Grants Commission has been providing financial assistance to the **Colleges for the following different schemes:**

1. Special scheme of construction of Women's Hostel for colleges.
2. Organising Conferences / Workshops / Seminars in Colleges.
3. Jubilee, Centenary grants to Colleges.
4. Scheme for providing one-time catch up grant to uncovered (Non-12B) Colleges.
5. Development of Sports Infrastructure and Equipment in Universities and Colleges.
6. For providing Additional Assistance to Universities and 5500 Colleges already covered u/s 12(B) of the UGC Act, 1956 (one-time grant).
7. Research Projects for Teachers – Minor (MRP).

Proposals of the eligible Colleges listed under Section 2 f and 12 B of the UGC Act have to be considered by the UGC as per Guidelines of the XI Plan Development Schemes. The Guidelines of the schemes are available on the UGC website www.ugc.ac.in.

The Colleges under NRCB Bureau may submit their proposals (the colleges are requested to send the proposals separately under each scheme) to the office of the undersigned in the prescribed format along with other necessary documents, duly forwarded through their affiliating University positively before **30th June, 2011**. Preference will be given to the Colleges located in Districts with concentration of weaker sections, including minorities.

The Colleges which have already availed / approved the grants under Additional Grant for Equipment **need not apply**.

The incomplete proposals and proposals received after 30th June, 2011 will not be entertained.

The proposals forwarded by the affiliating University will only be entertained.
