

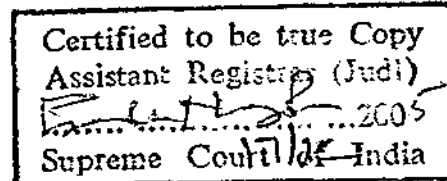

doing at his/her own risk."

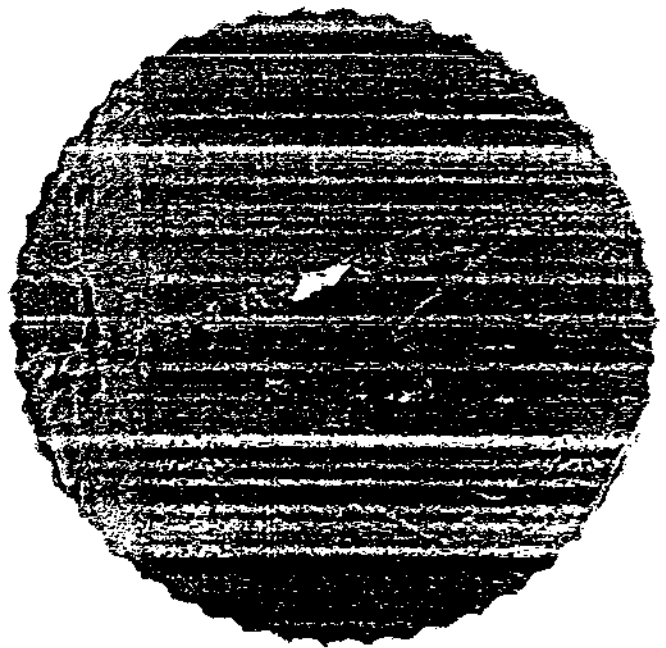
The Registrar General of this Court is directed to see that this
