The University Grants Commission invites applications for the award of **Post Doctoral Fellowship to Women Candidates for the year 2008-2009** from the unemployed Women Candidates those who are Ph.D. Degree in their respective subjects.

The objective of this award is to provide an opportunity to carry out the advanced studies and research in Science, Engineering and Technology, Humanities and Social Sciences in Indian Universities and Colleges recognized under UGC Act 2 (f) and 12 (B).

The candidate should not be more than 55 years of age as on 1st July of the year of award. The total duration of the fellowship is five years.
