Taking into account the recommendation as contained in the Reports of the Monitoring Committee & Subject Expert Committee and the presentation by you before the Standing Committee on UPE, the Commission at its meeting held on **18th October, 2011** had decided to approve the Phase-II of UPE scheme to your university.

On the basis above decision of the Commission, I am to convey the approval of the UGC for extension of UPE Phase-II in respect of Jadavpur University, Kolkata.
