Dear Shri Singh,,

This is in continuation of the visit of the UGC Visiting Committee to consider the XI Plan General Development Grant Allocation to your University.

- Based on the Report submitted by the XI Plan UGC Visiting Committee and availability of funds from the Government of India, UGC has approved the tentative XI Plan Allocation, subject to availability of funds from Government of India, in respect of your University as under:

(Rs. in Lakhs)

i) General Development Grant	976.25
ii) Merged Schemes	444.50
iii) Internal Quality assurance cell	5.00

- The 'on account' grant already under the above schemes released by UGC during XI Plan Period will be a part of XI Plan Allocation of the university. Further, funds for Merged Schemes is based on the eligibility criteria indicated in the XI Plan Guidelines. Therefore, the grant for each of the merged scheme will be released subject to the fulfillment of the eligibility criteria and other related norms as laid down for the purpose.
- A new scheme called Internal Quality Assurance Cell has also been included in the merged schemes and an additional amount of Rs.5.00 lakhs has been allocated to each State University. The Guidelines of this Scheme may be seen on UGC website www.ugc.ac.in
- The XI Plan Allocation is subject to compliance of the Academic Reforms as already circulated by the UGC vide its D.O.No.F.1-2/2008 (XI Plan) dated 30th March/21st April, 2009 which is also available on UGC website www.ugc.ac.in.
- In addition to above, the following Administrative Reforms may also be implemented:
 - Implementation of the Govt. of India Reservation Policy of SC/ST.
 - All Statutory posts should be filled up the appointment through Selection Committee as per the UGC Regulations.
 - All vacant Teaching Posts should be filled up expeditiously.
 - Annual Accounts, Annual Reports and Quality assessment Status Report should be submitted in time i.e. by 31st December of every year.
- The release of grant will also be linked to Academic and Administrative Reforms as well as compliance of various policies of Government of India rules.
- You are also requested to utilize proportionate grant on half yearly basis. Any portion which remain unutilized will be considered to be lapsed. UGC will also consider to

allocate the unutilized grant of the university to other universities which are better performing and are also following the various academic reforms as well as implementation of various policies of Government of India. Therefore, the University is advised to utilize the grant fully.

9. The amount recommended by the Visiting Committee for various merged schemes may be utilized as per guidelines of respective schemes available on UGC website. The anomaly if any as per pattern of assistance/guidelines may be brought to the notice of the Commission.
10. You are, therefore requested to re-work the priorities of university within the General Development Grant allocation as decided by the Commission and keeping in view the recommendation of the Visiting Committee. The revised proposal (item-wise and year-wise plan) in the prescribed format UGC (copy enclosed) may be sent within 15 days in duplicate along with the soft copy within the ceiling conveyed to University. After receipt of the item-wise allocation within the amount as decided by the Committee, the UGC will convey the final approval of XI Plan Allocation to the University.
11. A copy of the Report of the Visiting Committee is enclosed herewith for further necessary action at the University level.

PREAMBLE

The University, initially named Bhopal University, was set up in 1970 in the capital city of Madhya Pradesh. It was renamed Barkatullah Vishwavidyalaya in 1988, in the name of Shri Barkatullah, the great revolutionary and freedom fighter, who belonged to Bhopal.

The territorial jurisdiction of the University extends to eight districts of Madhya Pradesh, viz, Betul, Bhopal, Harda, Hoshangabad, Raisen, Rajgarh, Sehore and Vidisha. The University has 326 Colleges affiliated to it, out of which 64 are Govt. Colleges and remaining are Private Colleges imparting education in traditional as well as highly specialized job-oriented courses. There are 26 University Teaching Departments imparting graduate and post-graduate education. All PG programmes are run on semester basis in University Teaching Departments. The University conducts examination for over 1.40 lakhs students.

The University has a green, calm and serene campus spread over 400 acres of land a large portion of which is thickly wooded. Some of the important buildings in the University are: Administrative Block, Humanities Block, Biosciences Block, Institute of Management, Institute of Technology, Institute of Open and Distance Education, Physics, Pharmacy, Aqua-culture, Sports, Gymnasium. Besides there are staff quarters, Teachers' and Officers' quarters, VC's Bungalow, Health Centre, Post Office, canteen, etc.

Introduction

The Members of the Committee arrived at the Bhopal on 28-12-2008 and had detailed deliberations on various issues related to the assessment of the performance of Barkatullah University during X Plan Period and the utilization of the grants of the UGC, in terms of its basic principles of XI Plan – “**Inclusiveness**” which enfolds parameters like, Access, Equity, Quality, Relevance, and Governance apart from reference for evaluation of the University priorities and requirements during the XI Plan Period.

The Visiting Committee, under the chairmanship of Prof. D.P. Singh, Convener, met at 9.00 am on 29.12.2008 at the Vice-Chancellor's chambers, city campus, Bhopal. Dr. P Prakash, Member Secretary, briefed the Committee on the terms of reference of the Committee detailing the priorities of XI Plan and the role of the Committee on the assessment of X plan programmes, their implementation and utilization of plan grants apart from assessing the performance and its requirements under XI plan. The Convener briefed the Committee members on various issues related to plan grants and XI plans programme of action to be implemented by the University. The Visiting Expert Committee had its inaugural meeting with the Vice-Chancellor, Registrar, Deans, Principals, and other administrative officers of the University on 29.12.2008 at 09.30 am, and a detailed presentation was made by the Vice-Chancellor on the performance of Barkatullah University during X Plan period along with utilization of the X Plan Grants and the priorities and programmes of the University for XI Plan period. After preliminary discussions, the Members of the UGC visiting Expert Review Committee, visited the various central facilities to evaluate the requirement of the University for XI Plan period. The Committee had detailed deliberations with the faculty, students, non-teaching staff, and various functionaries of the University. The Expert Committee critically evaluated the requirements of the University as per the Guidelines of the UGC. The Committee appreciated the various recent initiatives taken up by the University for augmenting and

building up institutional needs. Subsequently the Committee divided itself into three groups and visited various departments. The observations, recommendations and suggestions made by the Committee are appended in the prescribed proforma. Prof. D.P. Singh, Convener and Dr. P. Prakash, Member Secretary, and other Members of the Visiting Committee thanked Prof. Bhupal Singh, Vice-Chancellor, the Registrar and other officials of Barkatullah University for their support in accomplishing the task of XI Plan Visiting Committee and placed on record the hospitality rendered by the institution during their visit and stay in Bhopal. The Committee expresses its special thanks to the secretarial assistance provided by Shri Madan Lal of UGC, New Delhi, for his commendable support in accomplishing the task.
