This is in continuation of the visit of the UGC Visiting Committee to consider the XI Plan General Development Grant Allocation to your University.

2. Based on the Report submitted by the XI Plan UGC Visiting Committee and availability of funds from the Government of India, UGC has approved the tentative XI Plan Allocation, subject to availability of funds from Government of India, in respect of your University as under:

(Rs. in Lakhs)

i) General Development Grant	609.38
ii) Merged Schemes	353.00
iii) Internal Quality assurance cell	5.00

3. The 'on account' grant already under the above schemes released by UGC during XI Plan Period will be a part of XI Plan Allocation of the university. Further, funds for Merged Schemes is based on the eligibility criteria indicated in the XI Plan Guidelines. Therefore, the grant for each of the merged scheme will be released subject to the fulfillment of the eligibility criteria and other related norms as laid down for the purpose.
4. A new scheme called Internal Quality Assurance Cell has also been included in the merged schemes and an additional amount of Rs.5.00 lakhs has been allocated to each State University. The Guidelines of this Scheme may be seen on UGC website www.ugc.ac.in
5. The XI Plan Allocation is subject to compliance of the Academic Reforms as already circulated by the UGC vide its D.O.No.F.1-2/2008 (XI Plan) dated 30th March/21st April, 2009 which is also available on UGC website www.ugc.ac.in.
6. In addition to above, the following Administrative Reforms may also be implemented:
- Implementation of the Govt. of India Reservation Policy of SC/ST.
 - All Statutory posts should be filled up the appointment through Selection Committee as per the UGC Regulations.
 - All vacant Teaching Posts should be filled up expeditiously.
 - Annual Accounts, Annual Reports and Quality assessment Status Report should be submitted in time i.e. by 31st December of every year.
7. The release of grant will also be linked to Academic and Administrative Reforms as well as compliance of various policies of Government of India rules.
8. You are also requested to utilize proportionate grant on half yearly basis. Any portion which remain unutilized will be considered to be lapsed. UGC will also consider to

The revised proposal (item-wise and year-wise plan) in the prescribed format UGC (copy enclosed) may be sent within 15 days in duplicate along with the soft copy within the ceiling conveyed to University. After receipt of the item-wise allocation within the amount as decided by the Committee, the UGC will convey the final approval of XI Plan Allocation to the University.
11. A copy of the Report of the Visiting Committee is enclosed herewith for further necessary action at the University level.

The Vice-Chancellor, **Prof. A Bhoomaiah** welcomed the Committee Members and introduced them to the Registrar, Dean (CDC), senior faculty members and Administrative Officers of the University. Thereafter, **Prof. Gowri Shanker, Registrar** gave a brief presentation on the present status of the University, its achievements during X Plan and its requirements for the XI Plan.

After formal discussions with the Vice-Chancellor, Registrar, Dean (CDC) and Senior Faculty Members, the Committee divided itself into the following two groups to visit the departments on 29th and 30th December, 2008.

The whole team visited the Central facilities namely, library, computer centre, administrative block and museum in the existing campus of the university.

The new campus having 100 acres area is under construction for which the land was allotted during 2003 and the UGC provided grant during X plan period for construction of building for the School of Fine Arts and partial grant for construction of Administrative Block building. These buildings are likely to be completed soon.

The Committee noted that major development of campus development in the new campus has yet to take place. Partial portion of boundary wall has been constructed. There is no pacca approach roads, street lights and other facilities in the campus except a boys hostel.

There is an urgent need of one-time special grant from UGC and State Govt. for creating infrastructure to enable the university to shift its Administrative and academic activities in the new campus in the near future. To apprise this position the Committee also met Hon'ble Governor of Andhra Pradesh, Shri N.D. Tiwari.

The Committee also met the teaching, non-teaching staff and students of various departments.

On the basis of detailed discussion, observation and visits on the spot the Committee gave its financial recommendations as detailed in the respective tables on the following pages.
