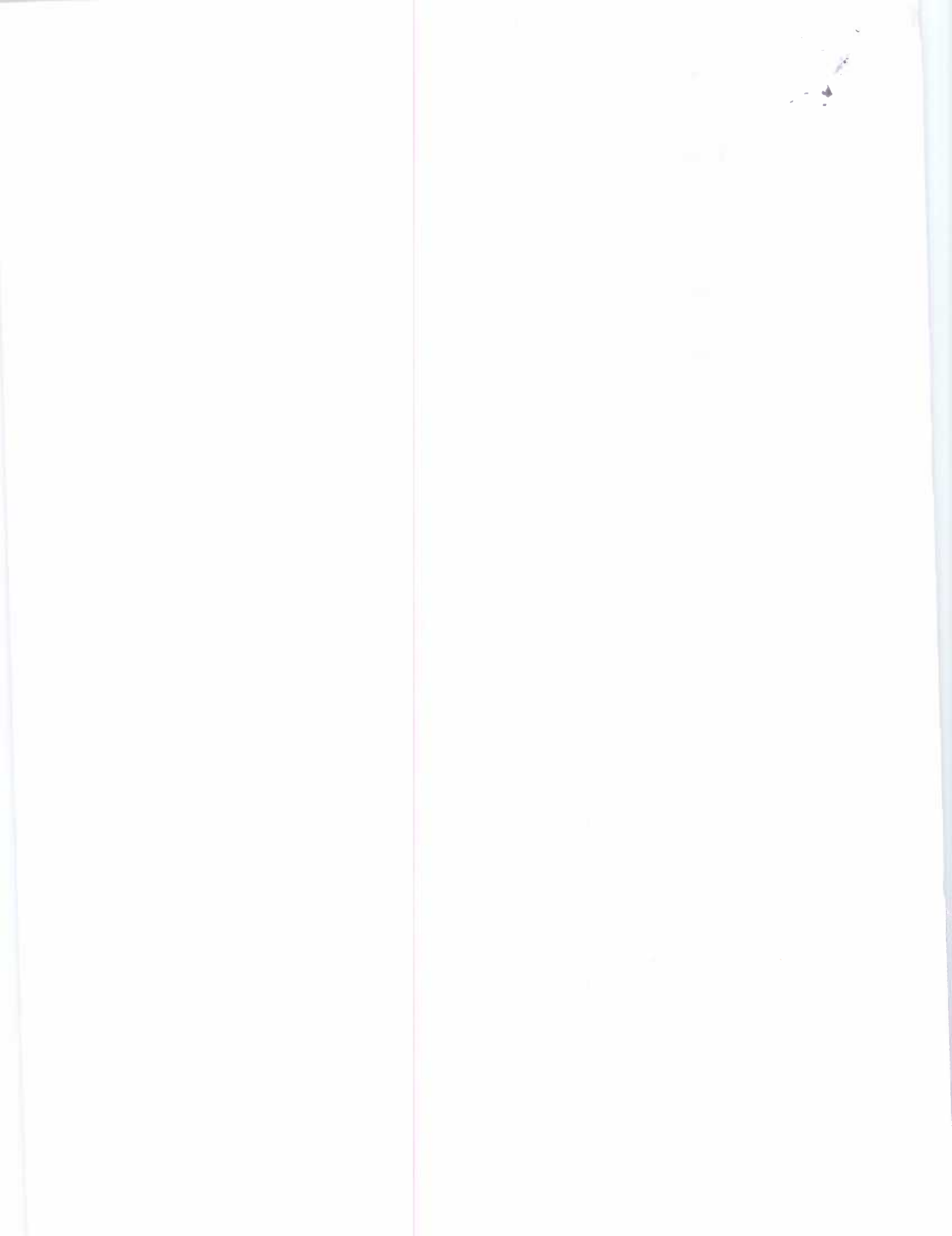
Dear Prof. (Dr.) Mohapatra,

This is in continuation of the visit of the UGC Visiting Committee to consider the XI Plan General Development Grant Allocation to your University.

2. Based on the Report submitted by the XI Plan UGC Visiting Committee and availability of funds from the Government of India, UGC has approved the tentative XI Plan Allocation, subject to availability of funds from Government of India, in respect of your University as under:

3. The 'on account' grant already under the above schemes released by UGC during XI Plan Period will be a part of XI Plan Allocation of the university. Further, funds for Merged Schemes is based on the eligibility criteria indicated in the XI Plan Guidelines. Therefore, the grant for each of the merged scheme will be released subject to the fulfillment of the eligibility criteria and other related norms as laid down for the purpose.
4. A new scheme called Internal Quality Assurance Cell has also been included in the merged schemes and an additional amount of Rs.5.00 lakhs has been allocated to each State University. The Guidelines of this Scheme may be seen on UGC website [www.ugc.ac.in](http://www.ugc.ac.in)
5. The XI Plan Allocation is subject to compliance of the Academic Reforms as already circulated by the UGC vide its D.O.No.F.1-2/2008 (XI Plan) dated 30<sup>th</sup> March/21<sup>st</sup> April, 2009 which is also available on UGC website [www.ugc.ac.in](http://www.ugc.ac.in).
6. In addition to above, the following Administrative Reforms may also be implemented:
- Implementation of the Govt. of India Reservation Policy of SC/ST.
  - All Statutory posts should be filled up the appointment through Selection Committee as per the UGC Regulations.
  - All vacant Teaching Posts should be filled up expeditiously.
  - Annual Accounts, Annual Reports and Quality assessment Status Report should be submitted in time i.e. by 31<sup>st</sup> December of every year.
7. The release of grant will also be linked to Academic and Administrative Reforms as well as compliance of various policies of Government of India rules.
8. You are also requested to utilize proportionate grant on half yearly basis. Any portion which remain unutilized will be considered to be lapsed. UGC will also consider to



allocate the unutilized grant of the university to other universities which are better performing and are also following the various academic reforms as well as implementation of various policies of Government of India. Therefore, the University is advised to utilize the grant fully.

9. The amount recommended by the Visiting Committee for various merged schemes may be utilized as per guidelines of respective schemes available on UGC website. The anomaly if any as per pattern of assistance/guidelines may be brought to the notice of the Commission.
10. You are, therefore requested to re-work the priorities of university within the General Development Grant allocation as decided by the Commission and keeping in view the recommendation of the Visiting Committee. The revised proposal (item-wise and year-wise plan) in the prescribed format UGC (copy enclosed) may be sent within 15 days in duplicate along with the soft copy within the ceiling conveyed to University. After receipt of the item-wise allocation within the amount as decided by the Committee, the UGC will convey the final approval of XI Plan Allocation to the University.
11. A copy of the Report of the Visiting Committee is enclosed herewith for further necessary action at the University level.

**REPORT OF THE XI PLAN VISITING COMMITTEE OF SHRI JAGANNATH  
SANSKRIT VISHVAVIDYALAYA , PURI , ORISSA**

**Report of the XI Plan Visiting Committee constituted by the Chairman, UGC to visit the Shri Jagannath Sanskrit Vishvavidyalaya , Shri Vihar , Puri , Orissa on 8<sup>th</sup> to 10<sup>th</sup> September 2008 to review the performance of the University during X Plan and to assess its requirements for the XI Plan.**

In a pre-visit meeting Prof. Satapathy , Convenor of the Committee welcomed the members and briefed them about the University and the work to be done by the Committee. Thereafter, the Committee had a meeting with Prof. G.P.Mohapatra , Vice Chancellor of the University who welcome the committee members and Registrar & Chairman , P.G.Council presented a brief profile of the University and gave information about the University's activities and achievements during the period of 10<sup>th</sup> five year plan. He also put forth before the committee a blue print of the proposed activities of the University alongwith the financial requirements for the XI Plan period.

The members of the committee together and in groups visited the following academic departments and centre of the university as well as its supporting units :

The members of the Committee during their visits to the departments and the centre had in depth discussion with the members of the faculty and got themselves acquainted with their activities. They also interacted with Administrative Staff of the University as well as a group of students to know from them their assessment of the achievements of the university and also the problems and difficulties which they are facing. The members of the Committee have also interacted with the non-teaching staff to know their problems and difficulties they are confronted with.

The members of the Committee also went through carefully the various documents which were presented to them in the departments and centre as well as those which were produced by the Chairman , P.G.Council . The Committee also had a detailed discussion with the Vice Chancellor and Registrar of the University about various issues related to the university. On the basis of these discussions which the members of the committee had and the documents with the members of the committee perused the committee would like to make the following observations and assessments of the performance of the university during the 10<sup>th</sup> Plan Period.

**A. Infrastructural Facilities**

The university was established in the year 1981 and during the period of 10<sup>th</sup> Five Year Plan, it has made commendable progress with regard to development of infrastructural facilities (buildings). During the 10<sup>th</sup> Five Year Plan, the university undertook construction work of various buildings for departments , auditorium, Staff III and Staff IV quarters, Guest house and Girls hostels, Health Centre etc.

**B. Campus Development**

During the period under review , the university has developed its campus. The development is quite impressive. There is a network of well constructed roads and plentiful plantations and landscaping all around the campus. . Every road has entry and exit gates too for security purposes.

**C. Equipment**

The University office and offices of the centres, departments etc. are very well furnished. Most of the departments and centres have computers softwares and other instruments. Student amenities, such as the provision for drinking water and sanitation are made in almost all the buildings.



#### **D. Academic Activities**

From the documents presented to the Committee and through the narrations of university authorities and faculty members, it was revealed that the university has been academically quite active and vibrant.

In order to have stability and commitment of teaching staff, the teachers should be appointed on regular basis as per the prescribed pay scales in all the courses . The service conditions such as leave rooms should be applied to all the teachers of aided scheme courses.

There should also be sharing of infrastructure, equipment and laboratory facilities among different departments and courses, self financing as well as aided.

#### **E. Central Facilities**

1. Women hostel building is ok but is inadequate keeping in the no. of women students .
2. Building of Health Centre is ready . All buildings sanctioned under X plan are completed and are in use .
3. No. of books in the library are encouraging but up keep is far from satisfactory .
5. The Gymnasium has equipment where students are everyday to work on their muscles . more equipment however is needed .
6. There is a need of appoint of Semi professional assistant in the departmental and central libraries .
7. The digital library concepts has to be apprehended .
8. There is an urgent need to make the teaching faculty and non teaching staff to be made computer literate. As such System Analyst , Programmers, Instructors , data entry operators be provided . This will also help the Computer Centre and institution in every way .
9. For efficient teaching pedagogy , LCDs ,computers needed to be provide.
10. Play grounds , campus development , Men Hostel , some roads needed a priority .

## Funds Utilization

The university had been allocated Rs. 235 Lakhs under 10<sup>th</sup> Five Year Plan. The details are as follows :

However due to certain insurmountable difficulties the university could not utilize the allocated funding for those specific purposes. According to the statement given by the Registrar of the university, the unspent amount from the sanctioned grants comes to 47 lakhs which may be taken as spill over amount to be accommodated in the proposed amount of funding to be sanctioned for XI Five Year Plan Period.

All departments may try for some kind of industry link to enhance their value. If permitted by the State Govt. the university may try to generate the funds through projects to sustain itself.

The vacant sanctioned posts of the teaching staff may be filled up immediately so that the students may not suffer in future.
