- (1) Please refer to my D.O. letter of even no. dated 31<sup>st</sup> December, 2008 (copy attached- Annexure-1) addressed to State Higher Education Secretary, regarding establishing model degree colleges in 374 districts in the country where the Gross Enrolment ratio in higher education is less than the national average.
- (2) It may also be stated that the Secretary, Ministry of HRD, Department of Education has also written in this regard to Chief Secretary of States/ UT's vide their letter D.O. No. 4-18/2007-U.II dated 3<sup>rd</sup> November, 2008.
- (3) I may further say that the proposed scheme for setting up of 374 model degree colleges in districts having Gross Enrolment Ratio of higher education less than the national average was considered by the Govt. of India, Expenditure Finance Committee in its meeting held on 9<sup>th</sup> June, 2009. The Committee had recommended the scheme with the following stipulations, among others:-
  - i. During the remaining period of the 11<sup>th</sup> Five Year Plan, assistance shall be provided for establishing 200 model colleges in identified districts with low GER, with priority being given to special category States and minority concentration districts as well as other districts in Schedule V and Schedule VI areas.
  - ii. The share of capital expenditure between Central and State Governments shall be in the ratio of 1:2. For Special Category States, the ratio will be 1:1. Any expenditure in excess of the projection made in the DPR will have to be met by the State Government. The State Governments will also have to undertake the full liability for recurring expenditure. For this purpose, a clear Memorandum of Understanding (MOU) will have to be signed with each State Government before any release of funds is made.
- (4) The UGC, at its meeting held on 4<sup>th</sup> August, 2009, (item No. 4.06) approved the guidelines for providing grant to universities/ colleges for setting up of 374 New model degree colleges in Educationally backward districts with low GER (copy attached- Annexure II including a list of 374 educationally backward districts is attached).

- (5) Since these newly established colleges would require time to fulfill the minimum requirements for being eligible under Section 12 B of UGC Act 1956, so the admissible grants to these new degree colleges in Low GER shall be released to the respective affiliating eligible University for development of infrastructure.
- (6) It may be mentioned that the Ministry of Human Resource Development, Department of Higher Education, Government of India, New Delhi, vide their letter No. F.4-18/2007-U.II dated 27<sup>th</sup> January, 2009 has informed that only Colleges established after December, 2007 when the National Development Council (NDC) approved the scheme can be covered under the scheme and not colleges set up in the identified districts of the country during the XI Plan period i.e. after April, 2007 (meaning April, 2007 to December, 2007 colleges established are not covered under the scheme of 374 colleges in Low GER).
- (7) In view of above the UGC financial assistance for establishment of Model Degree Colleges in Educationally backward districts will be available to the eligible universities which have been declared fit under Section 12 B of the UGC Act, 1956 for development of infrastructure in the Institutions concerned in respect of approved colleges established on or after 1<sup>st</sup> January, 2008 on receipt of detailed proposal along with the undertaking (copy attached) as per following pattern of assistance.

Total capital cost for establishment of college	-	Rs. 8.00 crore
Recurring expenditure (salary p.a.)	-	Rs. 1.00 crore*
Maintenance	-	Rs. 0.50 crore*

\* Recurring expenditure to be met fully by the concerned State Government.

Capital cost will be shared by the UGC and State Government as under:

Capital cost for establishment of college - Rs. 8.00 crore

Sharing basis (1/3 (UGC): 2/3 (State Govt.) - Rs. 2.67 crore (UGC)  
Rs. 5.33 crore (State Govt.)

### **Special Category States**

For Special Category States, the ratio will be 1:1. (50 (UGC) : 50 (State Govt.)

Capital cost will be shared by the UGC and State Government as under:

Capital cost for establishment of college - Rs. 8.00 crore

Sharing basis (50 (UGC) : 50 (State Govt.) - Rs. 4.00 crore (UGC)  
Rs. 4.00 crore (State Govt.)

- (8) Any expenditure in excess of the projected estimated cost will have to be met by the State Government. The State Governments will also have to undertake the full liability for recurring expenditure.

- (9) An undertaking by the State Government may be furnished before any release of funds is made in the format attached.
- (10) The guidelines, proforma proposal and undertaking format is also posted on UGC Web site [www.ugc.ac.in](http://www.ugc.ac.in)
- (11) I would like to request you to ask the concerned State Universities in your State to send proposals in the prescribed format attached with the guidelines to the UGC after obtaining the State Government's undertaking to contribute as per the pattern of assistance. A pro active approach of the State Government will enable the UGC to operationalise the scheme in the earliest possible time so that the new degree colleges are ready to commence academic operations from the academic session 2009-10.

In order to operationalise this scheme in a time bound manner, a meeting of the State Education Secretaries has been fixed on 19.9.2009 at 10.30 A.M. in the UGC Main Office, Bahadur Shah Zafar Marg, New Delhi. You are requested to attend the same along with the Vice Chancellor of the concerned University with all details.

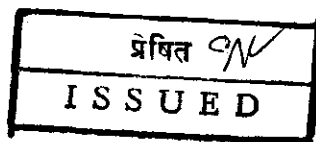

Dear Sir/ Madam.

As you are aware that the Government of India has been taking proactive measures for expansion of Higher Educational Facilities to ensure that all the states in the country achieve the national average of Gross Enrolment Ratio (GER) in Higher Education.

In the series of different policy initiatives of the Government, one important programmes is the Scheme of financial assistance by the Central Government to the states for establishing model degree colleges in 374 districts in the country where the Gross Enrolment ratio in higher education is less than the national average. The Central assistance under this scheme shall be provided through the UGC and will be limited to 1/3rd of the capital cost subject to a limit of Rs. 2.67 crores per college in the selected district and the balance requirement of the capital cost along with recurring costs would have to be met by the State.

In pursuance of this decision of the Government of India, the Commission had constituted an Expert Committee to prepare a Detailed Project Report (DPR) on the modalities for the execution of the scheme. The Report of the Committee was considered by the Commission in its meeting held on 21st May, 2008. The decision of the Commission on the report is as follows:

*“The Commission approved that the Report of UGC expert Committee to prepare model DPR for 374 New Colleges to be set up in Educationally Backward Districts (Low GER Districts in the country may be recommended and forwarded to Ministry of Human Resource Development. The Commission further decided that the state Governments may be asked to follow the model for the governance of the college either as constituent and autonomous as the situation warrants in the districts/state concerned. Since State Governments have to take care of the recurring expenditure of these colleges, the Commission desired that a discussion with State Governments may be convened by the Ministry of Human Resource Development before it is implemented. The commission further decided that Public- Private- Partnership could be considered by the State Governments in establishing these colleges.”*

A copy of the aforesaid Report is enclosed as Annexure- 1. The above resolution of the Commission has been aptly reflected in the letter D.O. No. 4-18/2007 –U-II dated 15th December, 2008 addressed by Shri R.P. Aggarwal, Secretary, Government of India, Ministry of Human Resource Development, and Department of Higher Education to all State Education Secretaries. The letter of the Higher Education Secretary also highlights the national importance of the scheme and urgency for its implementation.

It would be pertinent point out that the UGC Act does not allow the Commission to provide financial assistance directly to State Governments. Hence, this grants can be made available through the University under whose territorial jurisdiction, the proposed Model College is to be set up. This university will act as a Mentor to the College for all purposes. And the University so identified for receiving the assistance under the scheme should also be eligible under Section 12 B of the UGC Act of 1956. To pre-empt any legal complication, it is necessary that a State Government should identify only a university which is already eligible under Section 12 B or take necessary steps to get the University recognised for this purpose in accordance with the rules prescribed by the UGC. The UGC Rules for fitness of Universities for grants under Section 12 (b) of the UGC act, 1956 are available on the UGC Website [www.ugc.ac.in](http://www.ugc.ac.in).

In case, the State Govt. has already opened some colleges in the identified Districts during the XI Plan period i.e. after April, 01,2007- till date, such colleges can also be considered under this scheme.

In the above backdrop, I would request you to immediately identify suitable location for a degree college in each of your above districts in such Blocks or small municipal towns as would serve the weaker sections including the educationally backward minorities.

I would also request you to direct the concerned State Universities in your State to send appropriate proposals to the UGC after obtaining the State Government's willingness to contribute either on its own or through identified not-for-profit partners to meet the balance 2/3rd share of capital cost. This would enable the UGC to fast-track the proposal for release of Central share through its funding mechanism. A pro active approach of the State Government will enable the UGC to operationalise the scheme at the earliest possible time so that the new degree colleges are ready to commence academic operations from the academic session 2009-10.

## Guidelines for implementing the Scheme for providing financial assistance to New Model Colleges in Educationally Backward Districts (EBDs)

### **1. Introduction:**

While the growth of higher education in India over the past six decades has been visible and substantial, it has not percolated to all the regions uniformly. Based on Census 2001, 374 districts have been identified in the country, having Gross Enrolment Ratio (GER) lower than the national average of 12.4 per cent. A list of these 374 Educationally Backward Districts (EBDs) arranged state-wise may be seen at Annexure-I. The scenario hardly augurs well for an all-round and balanced social development in the states and in the country as a whole.

The Eleventh Five Year Plan emphasises on the need to increase the 'access' to higher education, especially in the EBDs. The UGC appointed a Committee of eminent educationists, which has since submitted a detailed report (also available on the UGC website: [www.ugc.ac.in](http://www.ugc.ac.in)) envisaging the establishment of a Model College (post senior secondary) in each of the 374 EBDs. Rural areas, reasonably well connected by transport facilities, may be accorded priority while setting up Model Colleges. A location which does not have a college within a radius of 10 kilometers is also to be given preference.

Subsequently, with the concurrence of the Ministry of Human Resource Development, Government of India, the UGC has evolved an innovative scheme to be implemented in all the 374 EBDs of the country by supporting the Model Colleges set up in these districts through appropriate financial assistance. The scheme shall be called the **Scheme for providing financial assistance to New Model Colleges in Educationally Backward Districts EBDs.**

## 2. Objective:

The main objective of the Scheme is to enhance the access to degree courses in EBDs of the country, so as to achieve expansion in higher education with inclusion, equity and quality.

The Scheme is essentially a motivational mechanism for State Governments to uplift under-served districts educationally by providing appropriate financial assistance.

## 3. Eligibility conditions:

- 3.1 The College has to be established under the new initiative of the Planning Commission and the Government of India pertaining to new degree colleges to be **set up during the XI Plan period, on or after 1<sup>st</sup> January, 2008**, that is after the National Development Council approved the new initiative and **located in EBDs, where the GER is less than the national average**. Basic information to determine the eligibility of the College must be furnished according to Section 1 of Annexure-II.
- 3.2 The State Government concerned shall acquire and allot adequate land to set up the Model College. Hilly or border areas and locations having a concentration of officially identified minority or tribal population may be accorded priority while setting up Model Colleges. A location which does not have a college within a radius of 10 kilometers is to be given preference.
- 3.3 The college shall preferably be a constituent unit of a University which is covered under Section 12B of the UGC Act or it shall have to be permanently or temporarily affiliated to a University, covered under Section 12 B of the UGC Act.
- 3.4 The college shall be receiving Plan and/or Non-Plan grant from the State Government and/or Central Government or State/ Central Government funded Bodies on continuous basis.
- 3.5 The State Government shall furnish an undertaking (Annexure III) that two-thirds of the non-recurring expenditure and the entire recurring expenditure shall be borne by it, and that it shall make provision for future appreciation in capital expenditure.
- 3.6 The affiliating University shall undertake that the funds provided to the college shall be utilized properly for the development of infrastructure.

#### **4. Preparation of Proposal:**

- 4.1 The State Government concerned shall decide the EBD where the Model College is to be located with due consideration to the priorities indicated under Sections 1 and 3.2 for setting up the Model Colleges.
- 4.2 The State Government shall identify the affiliating State University having jurisdiction over the EBD of the Model College.
- 4.3 The affiliating University shall prepare a detailed project report (DPR) and submit the same to the UGC together with the proforma at Annexure II, complete in all respects including justification for each item for which financial assistance is sought, along with its Undertaking and the Undertaking from the State Government.

#### **5. Nature of Assistance:**

- 5.1. It is estimated that setting up of one such Model College will initially require a non-recurring expenditure of at least Rs.8 crore and recurring expenditure of Rs.1.5 crore per annum (Rs.1.0 crore per annum towards salaries and Rs.0.5 crore per annum towards maintenance). The assistance from the Central Government through the UGC shall be limited to 1/3rd of the capital cost with a ceiling of Rs. 2.67 crore per college, and the balance has to be met by the State Government concerned, which will also provide the necessary land and the entire recurring expenditure. The State Government will also take care of the future appreciation in capital expenditure.
- 5.1 A. For Special Category States ratio of financial assistance will be 50 (UGC) : 50 (State Govt.) in respect of Capital expenditure.
- 5.2 The Model College may use the UGC assistance to construct/extend various types of building such as library, laboratory, classrooms, workshop shed, animal house, men's hostel, women's hostel, staff quarters, teachers' hostel (transit/ temporary), seminar hall, committee room, counseling cell,



auditorium, tutorial room, canteen building, non-resident students' centre, health centre, sports facility and others. The College shall follow the UGC Guidelines for the Construction of Buildings in this regard.

- 5.3 The financial assistance under the Scheme shall be available only up to the end of the XI Plan period.

## **6. Procedure for Release of Grant:**

- 6.1 An Expert Committee constituted by the UGC shall evaluate the DPR and look into the justification for seeking financial assistance from the Commission in respect of each item proposed by the college and accordingly shall submit its recommendations to the Commission regarding approval of the project and the quantum of grant. The decision of the Commission in this regard shall be final and binding.
- 6.2 If the project is approved, the UGC shall release 50% of the allocation approved by the Commission as the first instalment.
- 6.3 The second instalment of 40% of the allocation shall be released by the Commission only after the State Government concerned releases 50% of its committed share towards non-recurring expenditure and the recurring grant for at least one year, besides submission of the Utilization Certificate by the college in respect of the first instalment of grant released by the UGC.
- 6.4 The final instalment, limited to 10% of the allocation, shall be released on reimbursement basis after the completion documents of the building project(s) are submitted to the Commission.

## **7. Provision for collaboration:**

While setting up these colleges in the EBDs is essentially a joint initiative of the UGC and State Governments, the States will be free to collaborate with a non-profit foundation, trust or non-government organisation (NGO), or to enter into partnership arrangements with an organisation in 'public-private partnership' (PPP) mode. However, it shall be ensured that the PPP does not in any way adversely affect the access of disadvantaged sections of the population to higher education.

## 8. Advisory Committee:

8.1 Each Model College will have an Advisory Committee to oversee the academic and administrative functioning. The Advisory Committee may be headed by the Vice-Chancellor of the concerned University. The Committee may comprise:

8.2 The term of the Advisory Committee will be for three years or till the college starts academic programmes, whichever is later.

## 9. Monitoring:

The UGC shall monitor the implementation of this Scheme as a centrally sponsored programme through the affiliating University concerned. For this purpose, the College shall submit Annual Progress Reports to the Commission through the affiliating University.
