Sir/Madam,

In continuation to this office circular of even number dated 13.3.2003 (copy enclosed for ready reference) on the subject cited above, I am directed to inform you that the Commission in its meeting held on 9.4.2003, considered the guidelines for counting of past service for promotion from Reader to Professor and decided that past service of a Reader be considered for promotion to the post of Professor only if he or she had rendered his or her services in the same scale of pay [Rs.3700-5700 (pre-revised) Rs.12,000-18,300 (revised)] in the Government of India/State Government/ Autonomous Bodies of Government of India or State Government Laboratories and if he or she had possessed qualifications equivalent to that of Reader whilst working in the aforesaid institutions/establishments.
