Dear Dr. Prakash,

This is in continuation of the visit of the UGC Visiting Committee to consider the XI Plan General Development Grant Allocation to your University.

2. Based on the Report submitted by the XI Plan UGC Visiting Committee and availability of funds from the Government of India, UGC has approved the tentative XI Plan Allocation, subject to availability of funds from Government of India, in respect of your University as under:

	(Rs. in Lakhs)
i) General Development Grant	701.25
ii) Merged Schemes	141.00
iii) Internal Quality assurance cell	5.00

3. The 'on account' grant already under the above schemes released by UGC during XI Plan Period will be a part of XI Plan Allocation of the university. Further, funds for Merged Schemes is based on the eligibility criteria indicated in the XI Plan Guidelines. Therefore, the grant for each of the merged scheme will be released subject to the fulfillment of the eligibility criteria and other related norms as laid down for the purpose.
4. A new scheme called Internal Quality Assurance Cell has also been included in the merged schemes and an additional amount of Rs.5.00 lakhs has been allocated to each State University. The Guidelines of this Scheme may be seen on UGC website [www.ugc.ac.in](http://www.ugc.ac.in)
5. The XI Plan Allocation is subject to compliance of the Academic Reforms as already circulated by the UGC vide its D.O.No.F.1-2/2008 (XI Plan) dated 30<sup>th</sup> March/21<sup>st</sup> April, 2009 which is also available on UGC website [www.ugc.ac.in](http://www.ugc.ac.in).
6. In addition to above, the following Administrative Reforms may also be implemented:
- Implementation of the Govt. of India Reservation Policy of SC/ST.
  - All Statutory posts should be filled up the appointment through Selection Committee as per the UGC Regulations.
  - All vacant Teaching Posts should be filled up expeditiously.
  - Annual Accounts, Annual Reports and Quality assessment Status Report should be submitted in time i.e. by 31<sup>st</sup> December of every year.
7. The release of grant will also be linked to Academic and Administrative Reforms as well as compliance of various policies of Government of India rules.
8. You are also requested to utilize proportionate grant on half yearly basis. Any portion which remain unutilized will be considered to be lapsed. UGC will also consider to

allocate the unutilized grant of the university to other universities which are better performing and are also following the various academic reforms as well as implementation of various policies of Government of India. Therefore, the University is advised to utilize the grant fully.

9. The amount recommended by the Visiting Committee for various merged schemes may be utilized as per guidelines of respective schemes available on UGC website. The anomaly if any as per pattern of assistance/guidelines may be brought to the notice of the Commission.
10. You are, therefore requested to re-work the priorities of university within the General Development Grant allocation as decided by the Commission and keeping in view the recommendation of the Visiting Committee. The revised proposal (item-wise and year-wise plan) in the prescribed format UGC (copy enclosed) may be sent within 15 days in duplicate along with the soft copy within the ceiling conveyed to University. After receipt of the item-wise allocation within the amount as decided by the Committee, the UGC will convey the final approval of XI Plan Allocation to the University.
11. A copy of the Report of the Visiting Committee is enclosed herewith for further necessary action at the University level.

### BRIEF INTRODUCTION OF THE UNIVERSITY

The Rohilkhand University, Bareilly came into existence on February 15, 1975 by the Uttar Pradesh Govt. Notification No. 10-1135/1548 (ii)-74. Rohilkhand Region comprised of Bareilly, Pilibhit, Budaun, Shahjahanpur, Moradabad, Rampur, Jyotiba Phule Nagar, Bijnor districts covering an area of 17'362 sq. Kms. In 1997 the University of Rohilkhand has been renamed as Mahatma Jyotiba Phule Rohilkhand University vide notification of U.P. Govt. No. 1255/सत्रह.वि.1.1. (क) - 31-1997 लखनऊ dated 16.08.1997. The University was given a new face of affiliating - cum-residential University, in 1985 and four departments was sanctioned in the University Campus by the State Govt. and one department of Adult, Continuing Education and Extension was sanctioned by U.G.C. under third dimension of Higher Education in 1987 three more Departments Business Administration, Education and Law were further added. In October 1993, University was recognized by the University Grants Commission under section 12-B of its Act for developmental and financial assistance. The University entered in new era of need based innovative professional and Vocational education, the enrolment of students in University campus has increased from 200 to more than 3600 (more than eighteen times). The University at present examines more than 2.70 lakhs students across 12 faculties, studying total 70 courses in the University Department and its affiliated colleges out of which 20 professional and vocational courses are running in campus. Today it has achieved the status of one of the pioneer Universities in Higher Education particularly in professional and job oriented courses for integrated programme of teaching and promoting inter-disciplinary approach. In 1975 University had 29 affiliated colleges now 115 colleges are affiliated to the University out of which 4 affiliated colleges are devoted

only to professional courses. Proposals of many more professional colleges are under consideration for affiliation.

The University has 141 affiliated colleges (including 2 Dental and rest Graduate/Post Graduate Colleges) spread over in eight districts of Bareilly, Moradabad, Rampur, Jyotiba Phule Nagar, Bijnor, Shahjahanpur, Budaun and Pilibhit. There are postgraduate and under graduate courses related to Arts, Science, Agriculture, Commerce, Law and Education faculties in the Under Graduate and/or Post Graduate Colleges.

#### THE GOALS AND OBJECTIVES OF MJP ROHILKHAND UNIVERSITY:

1. To prepare selected students for the highest level of education in all subjects including technology and science aimed at producing competent, creative and imaginative engineers, scientists, lawyer, teachers, journalists eminent scholars and jurists.
2. To promote higher studies and research objectively for acquisition of knowledge by students and staff.
3. To attract distinguished faculty who by their scholarship, learning and research, contributed to the rapidly growing structure of knowledge and professional excellence.
4. To foster interdisciplinary approaches and interdepartmental involvement in the academic programmes through interaction of faculty and students at centres of mutual interest.
5. To promote interactive programme with industries, Government and Civil organizations through research, consultations and short term intensive courses on current developments in technologies and sciences.

#### ABOUT INSTITUTE OF ENGINEERING AND TECHNOLOGY :

The institute of Engineering and Technology (under Faculty of Engineering & Technology) is a constituent part of the MJP Rohilkhand University and located at its campus. The Institute commenced B.Tech. courses in areas of Electronics and Communication Engineering, Computer Science and information Technology and Electronics and Instrumentation Engineering from January 1996. Electrical and Mechanical Engineering Branches were started from July 1996. To enrich the technical stream, Chemical Engineering was introduced in 1998.
