Dear Dr. Pathan,

This is in continuation of the visit of the UGC Visiting Committee to consider the XI Plan General Development Grant Allocation to your University.

2. Based on the Report submitted by the XI Plan UGC Visiting Committee and availability of funds from the Government of India, UGC has approved the tentative XI Plan Allocation, subject to availability of funds from Government of India, in respect of your University as under:

(Rs. in Lakhs)

i) General Development Grant	1149.75
ii) Merged Schemes	481.10
iii) Internal Quality assurance cell	5.00

3. The 'on account' grant already under the above schemes released by UGC during XI Plan Period will be a part of XI Plan Allocation of the university. Further, funds for Merged Schemes is based on the eligibility criteria indicated in the XI Plan Guidelines. Therefore, the grant for each of the merged scheme will be released subject to the fulfillment of the eligibility criteria and other related norms as laid down for the purpose.
4. A new scheme called Internal Quality Assurance Cell has also been included in the merged schemes and an additional amount of Rs.5.00 lakhs has been allocated to each State University. The Guidelines of this Scheme may be seen on UGC website [www.ugc.ac.in](http://www.ugc.ac.in)
5. The XI Plan Allocation is subject to compliance of the Academic Reforms as already circulated by the UGC vide its D.O.No.F.1-2/2008 (XI Plan) dated 30<sup>th</sup> March/21<sup>st</sup> April, 2009 which is also available on UGC website [www.ugc.ac.in](http://www.ugc.ac.in).
6. In addition to above, the following Administrative Reforms may also be implemented:
- Implementation of the Govt. of India Reservation Policy of SC/ST.
  - All Statutory posts should be filled up the appointment through Selection Committee as per the UGC Regulations.
  - All vacant Teaching Posts should be filled up expeditiously.
  - Annual Accounts, Annual Reports and Quality assessment Status Report should be submitted in time i.e. by 31<sup>st</sup> December of every year.
7. The release of grant will also be linked to Academic and Administrative Reforms as well as compliance of various policies of Government of India rules.
8. You are also requested to utilize proportionate grant on half yearly basis. Any portion which remain unutilized will be considered to be lapsed. UGC will also consider to

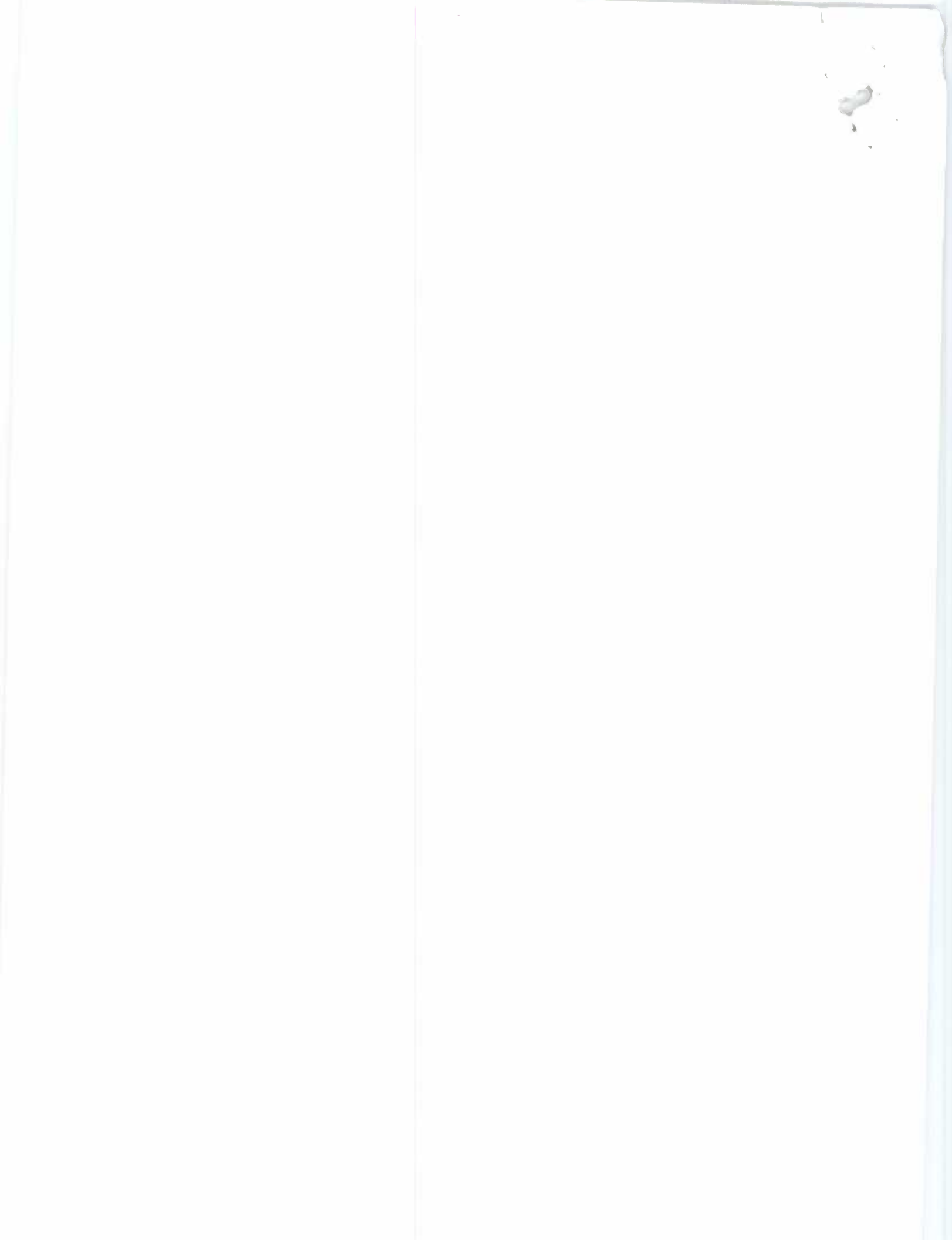

After receipt of the item-wise allocation within the amount as decided by the Committee, the UGC will convey the final approval of XI Plan Allocation to the University.

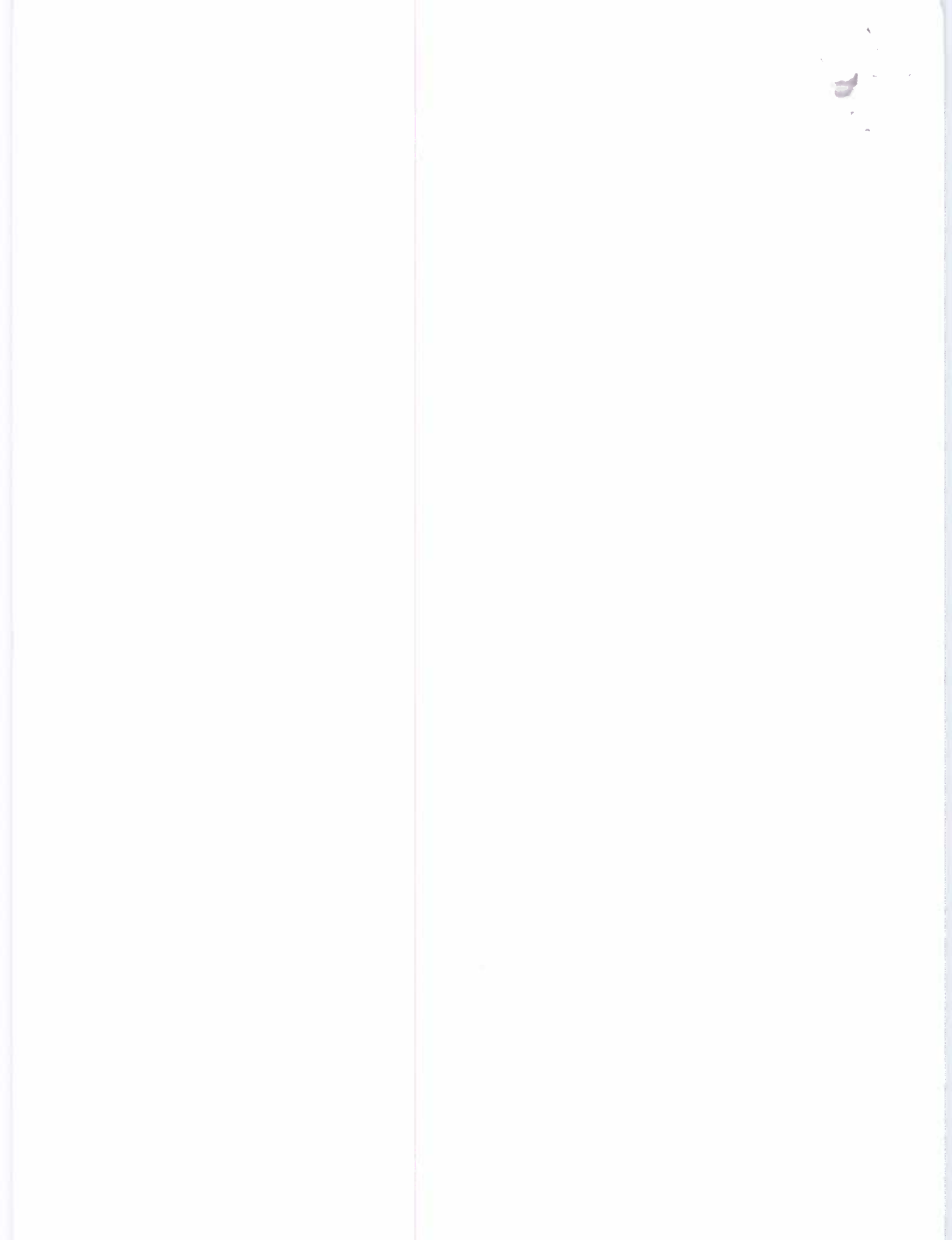

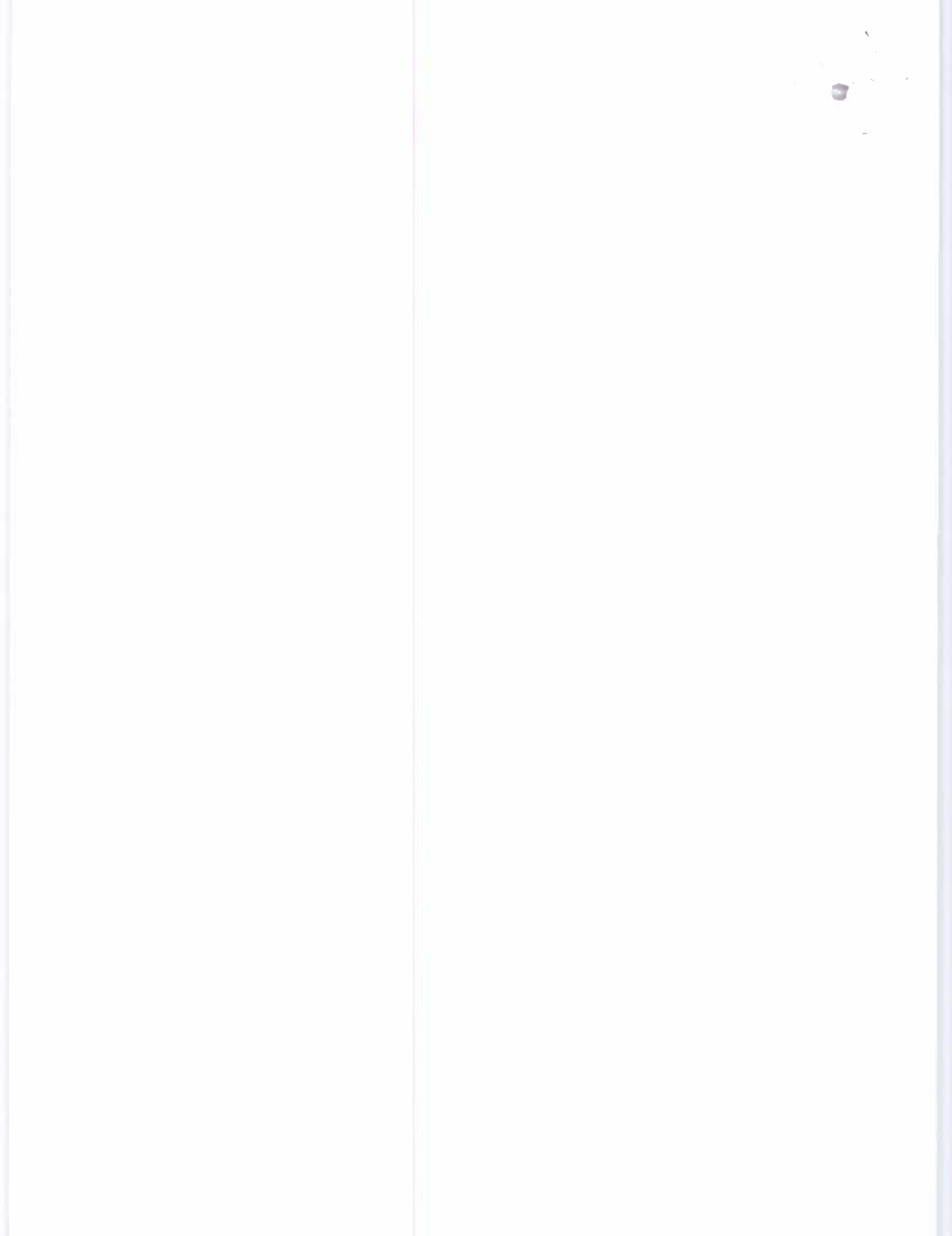

\*\* Prof. K.R.Naidu, Commission Member, UGC was initially chosen as the Convener of the Committee. However, as per communication from the UGC-XI Plan concerned dealing unit dated 2<sup>nd</sup> July 2008, there was a change of the Convener. The Chairman, UGC made a replacement of Prof. Naidu by Prof. S.D.Muni, a retired Professor of International Politics, School of Social Sciences, JNU who was communicated by letter (speed post) accordingly on 2<sup>nd</sup> July 2008. However, Prof. Muni, JNU was out of the country. The Chairman, UGC selected Prof Ashok Mathur, Former Professor, Centre for the Study of Regional Development, JNU and Visiting Professor. Institute for Human Development, New Delhi, initially identified as one of the Members of the Committee, to act as the Convener of the said Committee. Professor Mathur gave his consent on 03.07.2008 to act as the Convener of the Committee and to attend the meeting in the prescribed date. There was no confirmation from another Member of the Committee, Prof Satish Sabhrwal, Ex Professor of Sociology, JNU, New. The letter sent by speed post returned back. The matter was discussed with the Chairman, UGC and the Committee was finalized to go ahead with the meeting.

## BACKGROUND

Nagpur University was established on 4 August 1923 under Central Provinces Act of 1923. Rai Bahadur Bipin Krishna Bose was appointed as its first Vice Chancellor. Faculties and Boards of Studies were created and first Convocation of the University was held on 28 November 1924. The University started with 61 affiliated colleges from Jabalpur, Nagpur and Amravati and 927 students. Jabalpur, being a constituent part of its jurisdiction, was later included in Madhya Pradesh. During 1947, the number of students increased to about 9000, accompanied by the improvement and diversification of curricula and expansion in the range of subjects. The expansion of library and sports facilities occurred during these years for the intellectual and physical well being of the students. It was in 1958 that some new departments in Arts and Social Sciences faculties were opened; the major expansion, however, came in 1963 when several science and other departments were started. These departments were shifted to spacious buildings in the main campus in 1973.

**University Jurisdiction:** The jurisdiction of Nagpur University was then restricted to eight districts of Vidarbha. Subsequently, Punjabrao Deshmukh Krishi Vidyapeeth, an Agricultural University, was established in 1972 and 3 Agricultural colleges under jurisdiction of the university were affiliated to it. In 1983 a separate University for West Vidarbha was established at Amravati. During the period of eight decades of its existence the university has undergone fragmentation from time to time in terms of developments such as creation of Agricultural University (Punjabrao Deshmukh Krishi Vidyapeeth), Amravati University and Health Sciences University. Before the separation, Nagpur University had 142 affiliated colleges with 66,140 students. In 1983-84, after the establishment of Amravati University, the jurisdiction of Nagpur University was further restricted to 6 districts of East Vidarbha viz. Wardha, Nagpur, Chandrapur, Gadchiroli, Bhandara and Gondia and had 89 affiliated colleges with 45,299 students. Meanwhile, Maharashtra University of Health Sciences was established at Nashik and 12 colleges of health sciences from Nagpur University were affiliated to it. In UG courses. Nagpur University was renamed as Rashtrasant Tukadoji Maharaj Nagpur University in 2000. However, 85 years old University has occupied 327.57 acres of land with jurisdiction of six districts of Western Region (Nagpur, Chandrapur, Gadchiroli, Bhandara and Gondia), 167 buildings, 181044 students



**ty Status (Brief) :** RTM Nagpur University, a State Affiliating University, since its establishment in 1957 has now expanded to 10 Faculties, 36 university teaching departments (UTD), 4 centres, 1 conducted college (UC) providing higher education in university teaching departments / colleges with enrolments of students at UG (1<sup>st</sup> yr to 5<sup>th</sup> year as on 2006-07), 1826 students at PG (1<sup>st</sup> year to 3<sup>rd</sup> year as on 2007-08) at M Phil / PhD courses, 710 at diploma / certificate courses with a grant total in all these enrolment is 3684. The enrolment of SC/ST together out of the above covers 1085. The teaching strength in UTD/UC is 116 (out of 233 sanctioned posts), 56 (SC & ST together). In addition, there are now 11657 at PG (1<sup>st</sup> year to 3<sup>rd</sup> year), 186 at M Phil / PhD courses, 2386 at diploma / certificate courses with a grant total in all these enrolment of student is 101492. The filled in posts in UTD are 84 (out of 104 sanctioned posts) and the non teaching SC & ST posts in UTD are 31 (out of total filled posts). Non teaching filled posts in affiliated colleges are 1704 (out of total sanctioned posts), out of filled posts of non-teaching SC & ST together is 626 posts. All these show a huge sanctioned vacant posts which have not been filled in. This information sources is as per UGC/CT/273/0/882 dated 09.06.2008 of the University addressed to the UGC.

**University Departments** are English, Marathi, Hindi, Sanskrit, Pali & Prakrit, Linguistics, Economics, Political Science, Sociology, Public Administration, Philosophy, Psychology, Mass Communication, Indian History, Culture & Archaeology, Library & Information Science, Gandhian Thought, Fine Arts, Gandhian Thought, Geology, Biochemistry, Botany, Chemistry, Mathematics, Physics, Zoology, Microbiology, Economics, Law, Pharmaceutical Sciences, Home Science, Business Management, B Ed College, Electronics, Computer Science, Physical Education, PG TD Education. The University has four Centres like Gandhian Bio-technology Centre Center for Sericulture & Biological Pest Management Centre, Women Empowerment & Development Research, Inter Institutional Computer Centre and the only conducted college Laxminarayan Institute of Technology. The University runs courses, promotes and nurtures higher and secondary education in all these subjects which are leading to Master's and PhD Degrees. The University has produced and contributed human resources in these areas and in non-conventional subjects for 85 years which has helped to the cause of higher education growth and development.

**University Campuses:** The University has boys' hostels, pharmacy hostel, girls' hostel, a guest house, a technical staff college and a health centre. The entire activities of the University programmes / Courses, administrative functions, examinations are distributed in decentralized manner though its campuses as follows below:

**University objectives:** The University has been working with the objectives of

- (a) making higher education socially relevant
- (b) balancing the horizontal expansion
- (c) developing scientific and technical education involving students and teachers.

The **magnitude of the University** can be assessed in terms of:

- (i) its jurisdiction, which presently caters to the need of six districts including backward and tribal areas of Chandrapur and Gadchiroli,
- (ii) its large affiliating system consisting of more than 384 affiliated colleges in addition to its own 03 conducted colleges and 36 departments,
- (iii) its multi-faculty nature with Arts, Science, Social Science, Commerce, Education, Law, Home Science, Electronics, Computer faculties with a large number of subjects under each faculty, diversified and flexible course content. The University imparts knowledge through about 3000 teachers to about 1.82 lakh students appearing for different examinations annually.
