ADVERTISEMENT

The University Grants Commission invites applications for the award of Dr. S. Radhakrishnan Post Doctoral Fellowship (PDF) in Humanities and Social Sciences (including languages) for the year 2008-2009 to those candidates preferably below 35 years of age who have either received a Ph.D. degree or submitted their Ph.D. thesis are eligible to apply. It is necessary that candidate identify mentor for their postdoctoral research work and obtain his/her consent for the guidance. When, selected, those holdings the Ph.D. degree will be directly awarded the PDF. Those whose have submitted their Ph.D. thesis may be awarded a "bridging fellowship" (with marginally reduced stipend) until they are formally awarded the Ph.D. degree.

The fellowship will be awarded on a yearly basis with renewal/termination clause on the basis of PDF mentor/peer group appraisal. However, the maximum duration of the PDF award would be 3 years (Non-extendable). Candidate should give an undertaking in Annexure-I while availing the award, along with the endorsement of the research mentor that they would stay in place for a minimum of six months.

The objective of this award is to provide an opportunity to carry out the advanced studies and independent research in Humanities and Social Sciences (including languages) in Indian Universities and Colleges recognized under UGC Act 2 (f) and 12 (B).

The candidate should not be more than 35 years of age as on 1st July of the year of award. The total duration of the fellowship is **Three years** (non extendable)& financial assistance as under:-
