- (1) These Regulations may be called the University Grants Commission (the min mum standards of ins ructions for the grant of first degree through non-formal/distance education in the faculties of Arts, Humanities, Fine Arts, Music, Social Sciences, Commerce and Sciences) (first amendment) Regulations, 1995.
- (2) These shall come into force with immediate effect.
- (3) In the UGC (the minimum standards of instructions for the grant of first degree through non-formal/distance education in the faculties of Arts. Humanities, Fine Arts, Music, Social sciences, Commerce and Sciences) Regulations, 1985, "the words-age of 21 years, occurring in the last line of sub-clause (1) of clause (2) shall be substituted by the words-age of 18 years.
