POST DOCTORAL FELLOWSHIP FOR SC/ST CANDIDATES FOR 2013-14

University Grants Commission invites applications for the award of **100** Fellowships under the scheme of “**Post Doctoral Fellowship for Scheduled Caste & Scheduled Tribe Candidates**” for the year 2013-2014.

The objective of the scheme is to provide an opportunity to **SC/ST candidates** to undertake advanced studies and research in Science, Engineering & Technology, Humanities and Social Sciences in Indian Universities/Institutions/Colleges on **full time basis**.

Selection will be made on the basis of **merit through Interface Mode** by an Expert Committee constituted especially for the purpose. The guidelines of the scheme, detailed terms and conditions of the Fellowship, eligibility etc. may be seen by logging on the UGC website at (www.ugc.ac.in).

The University Grants Commission has recently revised the rate of fellowship, contingency & tenure under the scheme of Post Doctoral Fellowship for SC/ST candidates, which are given as under:-
