As per the decision taken in the meeting of the Committee held on 29.11.2013, the following two NGO/NGA made presentations on their relevant activities and produced evidences required for technical qualifications as mentioned below. Based on the presentation made and evidences produced for technical qualifications, the Committee decided that financial bid may be opened for M/s. Aman Satya Kachroo Trust for reasons mentioned below:-

S. No.	Name of NGO/NGA	Remarks
1.	Jahanvi (Reggd.), New Delhi	M/s. Jahanvi did not produce the relevant evidence of monitoring Anti Ragging activities for consecutive years that was essential technical requirement. In their presentation, they re-produced the anti ragging guidelines of the UGC and could not produce any evidence of activities to support their claim for having relevant experience. As such, the Committee decided not to consider their financial bid.




2.	Aman Satya Kachroo Trust, Gurgaon	M/s. Aman Satya Kachroo Trust could not produce relevant document for minimum receipt of Rs. 50.00 lakh in the financial year 2011-2012. However, they produced evidences for activities carried out by them to support their claim for relevant experience for past two years. The Committee decided to wave off the requirement of minimum receipt of Rs. 50.00 lakh in the financial year 2011-2012, considering the facts that this is the only NGO/NGA having relevant experience and is wholly devoted to the purpose of controlling anti ragging menace.

It was decided that the financial bid would be opened on 10th December, 2013 in presence of all the members including representative from the MHRD.




