The Ministry of Human Resource Development, vide letter No. 1-7/2015-U.II (2) dated 2<sup>nd</sup> November 2017, has revised the Pay Scales for the posts of Registrar, Deputy Registrar, Assistant Registrar, Controller of Examination, Deputy Controller of Examination, Assistant Controller of Examination, Finance Officer, Deputy Finance Officer and Assistant Finance Officer following the revision of Pay Scales of Central Govt. Employees on the recommendations of the 7<sup>th</sup> Central Pay Commission.

The UGC constituted a Committee under the Chairmanship of Prof. Sushma Yadav (Member UGC) for formulation of appropriate regulations in the matter in the light of the MHRD instructions vide their letter No.1-3/2017-U.II dated 13<sup>th</sup> November, 2017 and 8<sup>th</sup> January, 2018 as per the following terms and reference:

- (i) To examine the existing minimum qualification and other service conditions of Registrar, Deputy Registrar, Assistant Registrar, Controller of Examination, Deputy Controller of Examination, Assistant Controller of Examination, Finance Officer, Deputy Finance Officer and Assistant Finance Officer and equivalent Cadres in Universities & Colleges.
- (ii) To frame minimum qualifications and other service conditions of Registrar, Deputy Registrar, Assistant Registrar, Controller of Examination, Deputy Controller of Examination, Assistant Controller of Examination, Finance Officer, Deputy Finance Officer and Assistant Finance Officer and equivalent Cadres in Universities & Colleges.
- (iii) To Frame the guideline for promotion in respect of the Cadres of Registrar, Controller of Examination and Finance Officer and equivalent Cadres.
- (iv) To look into the cases anomalies, if any, in the matter of promotion for cadres of Registrar, Controller of Examination and Finance Officer and equivalent cadres and to suggest remedial measures.

Specific suggestions/ inputs confining strictly to the terms of reference as above are invited from the stakeholders for consideration by the Committee.
